

INTRODUCTION

Macedonian Association for Geotechnics (MAG) was established in 1999, and two years later it was accepted as a full time member in the International Society for Soil Mechanics and Geotechnical Engineering (ISSMGE). Among the other activities, it organized the promotive 1st symposium in 2002, and encouraged by the interest of engineers and academics for geotechnics, in 2006 it was host of the IInd symposium. After the initiation of MAG, and in cooperation with ISSMGE, this year we are organizing International seminar on Eurocode 7 and geotechnical aspects of Eurocode 8, where lecturers will be experts involved in preparation of Eurocodes.

GOALS OF THE SEMINAR

The International seminar is organized with goal to inform not only the members of MAG, but also the practitioners and academics in the country and region, with the basics, achievements and application of the European standards in the field of geotechnics. That is the reason why international experts in these important topics were invited. Of course, this seminar would also serve as a possibility for local and regional communication and cooperation in the field of geotechnics. Proceedings and CD containing the lecture material on EC 7 and geotechnical aspects of EC 8 will be published from the seminar.

Official language of the seminar will be English. Simultaneous translation on macedonian language will be provided.
